You transfer your deposit of management of the company and agree that these funds will be used at the discretion of austia-investment management.

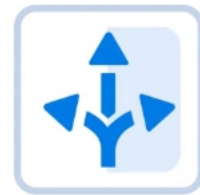

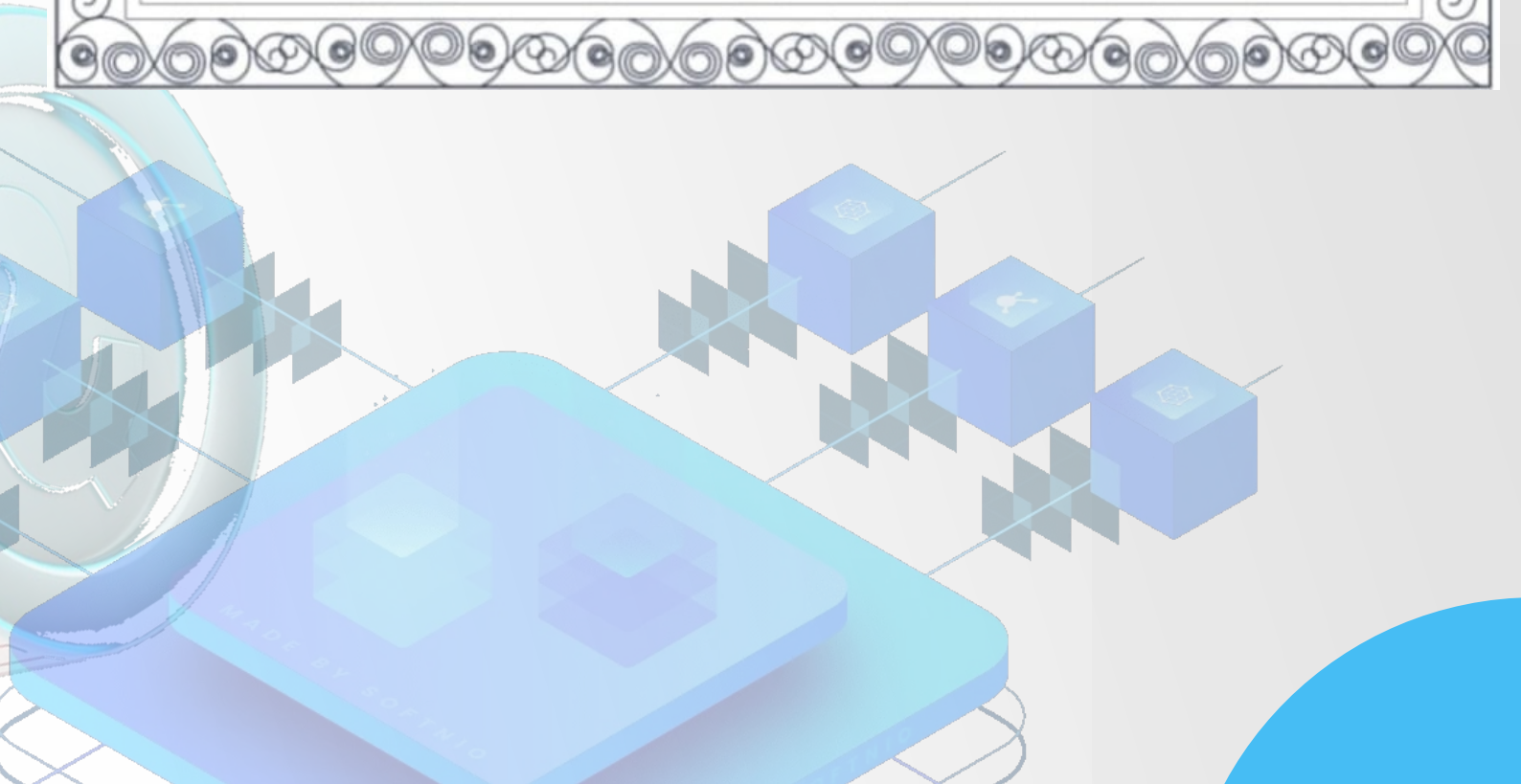
